#### **Directions to Meeting Point:**

Stourhead is on the B3092, north of Mere off the A303. Follow signs to Stourhead. After approx <sup>3</sup>/<sub>4</sub> mile take a left turn signed Gasper (single track lane). Then follow BWWGS signs. From the north A361 Frome, take the B3092 (through Maiden Bradley). Take main turn to Stourhead. Go past the Spread Eagle Pub, go under the stone arch bridge and turn immediately right.

- Handlers please bring two canvas dummies
- Please note caged game and cold game may be used in the tests
- Refreshments drinks and bites will be available
- Please keep all dogs on leads except when participating in tests or in a designated exercise area
- No person shall carry out punitive correction or harsh handling at a GWT
- J(G)4e. The organisers have the power to exclude dogs from the competition and will have the right to refuse an entry
- No bitches in season allowed on the test ground
- If a dog or handler is found to be entered in a class for which they do not meet the entry criteria any awards may be withheld or revoked.
- All handlers to be over 16 years of age, unless the dog is accompanied by registered owner at all times.
- Dogs must not be left unattended in cars due to the risk of overheating
